## EU/ECE type approval

Enter the European market with your compliant automotive products

### Your challenges

Europe is one of the world's top automotive markets. However, exporting to it can be a daunting prospect for distributors and manufacturers that are unfamiliar with the homologation process and the related EU/ECE regulations.

Obtaining the type approval for both whole vehicles and automotive components can be a complex process, as it involves a detailed assessment of the product's performance and a thorough appraisal of the testing facility. Manufacturers are also required to prepare and submit comprehensive documents for the type approval, including technical specifications of the product to be certified.

### Why is EU/ECE type approval important for your business?

To enter the European market, component manufacturers and OEMs must ensure that their products comply with the relevant EU/ECE regulations. The EU/ECE type approval is a mandatory requirement for whole vehicles,

as well as for a range of automotive systems and components, such as coupling devices, lamps or tyres.

For self-propelled working machinery that is not covered by these vehicle categories, we are appointed by the German government for national type approval testing. Additionally we are appointed by the German type

approval authority “Kraftfahrt-Bundesamt (KBA)” to carry out conformity of production (CoP) clearance testing and inspection. Particularly for manufacturers outside of the EU, this will reduce costs of homologation.



The EU/ECE type approval can be complex, so our technical service team supports you at every step, to ensure that nothing is missed. Once all technical documentation and the test report, as a result of the conducted performance assessment, is completed and conformity of production clearance has been granted, applicants will be issued with a type approval certificate. Manufacturers are then able to affix the type approval mark to their compliant components, and issue certificates of conformity (CoC) for vehicles using them.
